Licensee shall deposit \$100.00 for the reservation of premises, which sum shall be held against  
cancellation of the permitted use or as security against damages to the premises. In the event the premises  
are returned to the Fire Company in the same good condition and repair as given to Licensee, reasonable  
wear and tear excluded, said deposit will be returned.

Licensee shall be responsible for all damages to the premises. In the event of damages, Licensee  
shall immediately undertake to remove any hazard which may result therefrom and report same to the Fire  
Company. All such damage shall be repaired by repairman selected and directed by the Fire Company. All  
charges will be billed to the Licensee, who shall promptly pay the bill.

Licensee shall at conclusion of licenses term undertake a rough cleanup of the premises, all their  
food, garbage, rubbish (containers provided) and gather and case all bottles (storage provided until picked  
up). If rough cleanup is not made, deposit is forfeited.

It is further understood and agreed that the Fire Company will provide to the Licensee (only) table  
and chairs for up to two hundred fifty (250) diners.

Payment in full must be made thirty (30) days before effective date of license.

It is understood and agreed that Licensee shall provide their own insurance coverage for the  
duration of the rental, and expressly agrees to hold the Fire Company harmless for any and all incidents  
arising from or a result of said activity.
